## **Key Discussion**

Key discussion at this month's meeting included important updates from the HRMIS program and other major ICT programs, as well as a report from the Finance, Risk and Audit Committee meeting held in April 2024.

The Board endorsed the approach to the HSS Strategic Plan Review and were provided with an overview of one of HSS' strategic risks. The Board also received an update on the end-of-year financial position for HSS and noted the Service Level Agreement KPI performance for the previous month.

# **Chief Executive's Update**

The Chief Executive provided an update on the key achievements and issues across HSS in April 2024. These included:

- The System Flow and Reform (SF&R) Program has progressed the State Health Operations Centre (SHOC) Infrastructure procurement activities and planning to support the move to the new Command Centre.
- The Critical Health ICT Infrastructure Program (CHIIP) is on track to delivering the required outcomes.
- HSS continues to progress with the planning and execution of the Long Service Leave (LSL) for Casuals project. This project is being delivered in four stages, with high level planning completed for each. The current focus is on Stage 1, with a consistent approach to paying casual employees LSL entitlements being determined across government.
