

HSS Board Communiqué March 2022 Meeting

Key Discussion

The Board held a wide-ranging discussion regarding various topics across all HSS Business Units. This month, the HSS Finance Risk and Audit Committee provided their first update to the Board for 2022. This included recommending the Board approve the updated HSS Risk Management Framework which outlines how HSS manages operational and strategic risks.

A briefing was provided by the <u>Independent Governance Review Panel</u> regarding the terms of reference for the review, and the approach and issues identification work that will be undertaken. The Board welcomed the opportunity to hear from the panel and provide feedback as it related to HSS.

The HSS Strategy Implementation Plan and associated Key Performance Indicators were endorsed by the HSS Board. This document outlined all of the work packages HSS will implement in order to deliver on the HSS Strategic Plan 2022-24.

Chief Executive's Update

This month's update focussed on the key achievements and issues across HSS in February 2022. These included:

- The operationalisation of the HSS COVID-19 Coordination Centre, whose focus is monitoring the daily impact of COVID-19 on HSS' workforce and performance.
- HSS' Service Level Agreement performance for January 2022.
- Progress of all major programs, including the mobilisation of the Human Resource Management Information System Program team for the implementation and delivery phase of the program.
- The commencement of the Annual Financial and General Computer Controls Audits by the Office of the Auditor General for the 2021-22 Financial Year.

- HSS Internal Audit Plan 2021-22.
- HSS Risk Management Framework.
